



Terms & Conditions for competition #24DaysOfFreeletics

1. Promoter

This promotional competition is run by Freeletics GmbH, Lothstraße 5, 80335 Munich, in the following "Freeletics".

2. Conditions of participation

To enter the competition entrants must use the Freeletics Training App and have a public profile in the app. They must complete at least 1 of the 24 required exercises within the particular time frame (December 1st until December 24th, 2019) and post this to the Freeletics Training App feed with the #24DaysOfFreeletics. By entering all entrants agree to be bound by these terms and conditions. Information and details about this challenge are available on the [Freeletics Blog](#).

It is a prerequisite for participation to have an existing user account at Freeletics and a public profile within the application. If the entrant does not yet have a user account for the Freeletics services, the entrant can open one. Only natural people of full age are eligible to participate. The employees of Freeletics GmbH and its affiliated companies as well as their relatives and all other parties involved in the execution of the competition are excluded from participating in this competition.

Automatically generated entries (e.g. via lottery service providers etc.) are void. In any case of a breach of these terms and conditions or the influence on equal opportunities, e.g. by technical manipulation, or a similar serious violation, Freeletics may, at its own discretion, terminate the participation of the entrant or change the terms and conditions of the competition. The participation in this promotion is free of costs.

If a non-eligible participant is determined to be a winner, he/she will be denied the prize the Promoter reserves the right to re-select another winner from the valid/correct entries that were received before the Closing Date.

3. Prize

1 final prize: 24 days of Freeletics Training Coach for free and 1 Freeletics package including a branded t-shirt, a branded bottle, a happy strappy, a bracelet, stickers and other surprises at the discretion of Freeletics.

24 daily prizes: each 24 days of Freeletics Training Coach for free.

NOTE: the Freeletics Training Coach will automatically renew after these 24 days, if the participant does not actively terminates the subscription.



4. Procedure

The competition takes place in the period December 1st – December 24th, 2019. Freeletics will publish one exercise per day via the Official Freeletics Profile in the feed in the app.

Participants enter the competition by completing the daily exercises during the given time frame and posting this in the Freeletics Training app feed with the hashtag #24DaysOfFreeletics on a daily basis. The participant must have an existing user account with Freeletics GmbH during the entire competition period.

Only posts that fulfil all aforementioned criteria participate in the competition. Competition closes at 23:59 on December 24th. Entries received after the closing date (depending on your time zone) will not be counted.

The final prize will be raffled off between all participants who have participated in all 24 days and have completed all 24 exercises as described above.

The daily prizes will be raffled between all the participants that completed an exercise as described above on that specific day.

The prize is non-transferable and non-refundable. No cash alternative is available in whole or in part.

The winners will be randomly selected from all valid entries for this competition received before the Closing Date.

Winners will be notified via email (using the Freeletics Account Email-address) within 5 days after the Closing Date. All reasonable endeavours will be made to contact the winner. If a winner cannot be contacted or is not available, the Promoter reserves the right to re-select another winner from the valid/correct entries that were received before the Closing Date.

5. Warranties and publications

The participant declares by participating in the competition that the respective e-mail address is his own and is not owned by a third party. Should third parties file any claim against the promoter for infringement of their rights in connection with the respective email address, the participant bears full responsibility for the damage suffered by the third party.

The winner agrees that his/her name and country of registration are being published on the Freeletics Blog and on social media (@freeletics).

6. Data Security - Declaration of consent

As far as personal data from participants are collected in the course of the competition, these are collected, processed and used by the promoter solely for the purpose of carrying out and processing the competition. The data will be deleted within 30 days after the competition has been carried. The participant may object or withdraw his consent at any time for the future. 7. Granting of rights

Daily winners will be announced within the app via the official Freeletics profile within the app. Therefore, by participating in this competition, the winners give permission for their names and countries of registration to be used in Freeletics own channels such as the Website, Blog and Social Media accounts or for other PR-purposes.

8. Miscellaneous

If individual provisions of these terms and conditions are illegal, invalid or unenforceable, this shall not affect the validity or enforceability of any other provision.

Freeletics reserves the right to change the terms and conditions for competition at any time for the future.

There is no right of appeal. Jurisdiction is Munich.
